## Guidelines and Entry Requirements

This exhibition salutes the work of our members and students. Each year, the Lighthouse Center for the Arts offers an opportunity for our artists not only to show their work but to offer their artwork for sale to the community. Works hung in the exhibition will be priced according to the artists' stated price, and all sales of exhibited artwork during the exhibition will be handled through the Lighthouse Center for the Arts. A 20% fee on each sale will help us support operations and overhead. Artists will receive a check through LCA for 80% of the sale price within 30 days after the conclusion of the exhibition.

### **Artwork Drop-off date:**

Monday, March 29, 2010, between the hours of 10 a.m. and 4:30 p.m.

No late works will be accepted after this date without prior arrangement with the curator, Shannon Frezza.

### **Artwork Pick-up date:**

Wednesday, April 28, 2010 between the hours of 1 p.m. and 4:30 p.m.

There will be a storage fee of \$5 per day for works not picked up on time without prior arrangement. Works not picked up within 30 days will become the property of the Lighthouse Center for the Arts.

### **Artists' Opening Reception and Awards**

Receptions and Awards will be on  
Thursday, April 8, from 5:30 p.m. to 7:30 p.m.  
The exhibition will run through April 27<sup>th</sup>.

### **Entry Fee**

Please issue a non-refundable fee of \$25 each for up to two works of art payable to the Lighthouse Center for the Arts. Payment must be received at the time of delivery.

## Eligibility

This non-juried exhibition is open to all artists who are current members or have been registered students at LCA since September 1, 2009.

**Not a member?** Support the Lighthouse Center for the Arts by joining when you drop off your work.

- All artwork and sources must be original and only attributable to artist.
- Photo reference sources may be used but must be included with the application.
- No copies. Work must have been completed within the last calendar year.
- Any work previously exhibited at LCA is not eligible.
- Painting size not to exceed 36" x 48" including multiple panels or pieces.
- All work must be priced or be marked not for sale (NFS).
- Artwork must remain on display for the entire exhibition.
- **No early pick-ups.**
- LCA faculty are encouraged to exhibit but are not eligible for awards.
- All 2-dimensional works must be framed and wired securely. Pieces without hanging wires will not be hung.
- Unframed canvas works must be finished on all sides, wired and ready to hang.
- Pedestals will be provided by LCA for all 3-dimensional works.
- Each artist may submit up to 2 pieces of artwork.
